B. A. - 60 Seats (Pol. Science, Hindi litt., Sociology and Geography) with compulsory subjects

### Conditions:-

- I. To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and instructions framed, amended, adopted and issued from time to time in general and specifically relating to :-
  - (i) Admissions of students in all the Courses.
  - (ii) To follow curricular/ courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
  - (iii) Appointment of Sports/ PTI/Library Staff.
- II (i) STAFF:- Appointment of permanent and qualified Principal and Teaching Staff on the full time basis selected by a duly constituted Committee.
- (ii) BUILDING:- Construction of sufficient building, play grounds and hostel building as per guidelines of the University within stipulated time.
- (iii) LIBRARY:- Year-wise development of College Library and provision of funds for journals and magazines be made.
- (iv) ENDOWMENT FUND:- sufficient endowment fund as prescribed in rules be created.
- (v) FACULTY MEMBERS:- At least two faculty members in each faculty be appointed as per the decision of the Academic council and Board of Management already circulated to the Principals of all the affiliated colleges of the University.
- III. (i) To provide the information as asked by the University from time to time including Statistics etc.
- (ii) The College will abide by with all the rules and regulations of University of Kota, Kota.

### Conditions as per inspection report:-

1. Principal is above the age of 60. The new appointment of Principal is to be appointed.
2. Faculty members of the college are to be appointed as per the guidelines of the University.
3. College fund is to be developed.
